- * Participate in the strategic planning activities of the School of Pharmacy.
- * Maintain current and archive files of HLC and ACPE accreditation standards.
- * Monitor changes from the accreditation governing bodies. Coordinate ongoing and routine faculty development relating to the accreditation process.
- * Participate in ACPE and HLC conferences.
- * Manage assessment plans and performance measures. Facilitate prioritization and completion of tasks of each assessment period.
- * Represent the School of Pharmacy at institutional accreditation meetings.
- * Committee work at both the college and university level.
- * Other duties as assigned by the Associate Dean.

Minimum requirements include masters in business or education-related fields (Ph.D. or equivalent preferred), and at least two (2) years of management experience. Those with pharmacy degrees and/or experience in a higher education environment with experience in assessment, accreditation reviews, or audits are preferred.
